

- I declare that
 - the information given in support of this application is accurate and complete.
 - I have obtained results of my Hong Kong Diploma of Secondary Education ("HKDSE") Examination / or expect to obtain them in 2026.
 - I am NOT currently enrolled in any full-time bachelor's degree programme offered under Joint University Programmes Admissions System ("JUPAS") by any of the 9 JUPAS participating institutions (namely (1) City University of Hong Kong ("CUHK"), (2) Hong Kong Baptist University ("HKBU"), (3) Lingnan University ("LNU"), (4) The Chinese University of Hong Kong ("CUHK"), (5) The Education University of Hong Kong ("EDUHK"), (6) The Hong Kong Polytechnic University ("PolyU"), (7) The Hong Kong University of Science and Technology ("HKUST"), (8) The University of Hong Kong ("HKU"), and (9) Hong Kong Metropolitan University ("HKM")) in the Study Scheme for Designated Professors / Factors ("SSDP") programmes offered by the SSDP institutions (collectively be referred to as the "Institutions").
 - I am currently a local applicant according to the definition provided by the Education Bureau (EDB) (Read "Definition").
 - I have read and understand the Online Application System User Guide for Applicants / Applicants' User Guide(s) in relation to the submission and the whole process of my JUPAS application. I understand that if there is any discrepancy between the English and Chinese version of the Applicant's User Guide, the English version shall prevail.
- I understand and accept that

For ALL Applicants

 - the entire application procedure will be processed online, and it is my responsibility to check all information and all message(s) sent by the JUPAS Office and the Institutions (whether by post, via phone, Online Application System, email and / or SMS) as they may contain important information regarding my application. I also understand that no reminders will be sent to me, and if for any reason I fail to check such information I will bear the consequences of missing the information / message(s).
 - it is my responsibility to ensure that my contact information (such as email address, phone number(s) and mailing address, etc.) is correct and up to date, otherwise I may not receive important messages and correspondence from the JUPAS Office and the Institutions.
 - if I make any changes to my application, it is my responsibility to retain a copy of the confirmation page and confirmation email (if applicable) as proof that such changes have been made. I also understand and agree that in the event of any dispute or queries, the JUPAS Office will only accept the retained copy of the said confirmation as official evidence, and no other documentation in any format will be accepted; and
 - the final decision on admission will be subject to the authenticity of the information as listed in my application. I may be requested to produce original copies of documentation acceptable to the Institution concerned for verification when required; if I fail to do so, my JUPAS application may be disqualified, or the Institution concerned may withdraw or amend my offer, or cancel my registration / enrolment, or terminate my studies.

For Applicants who belong to NLS – 9 in accordance with the EDB "Definition of Local Students" (Read "Definition")

 - notwithstanding that JUPAS accepts my application, I should not assume that my "local" status will remain unchanged after this acceptance;
 - it is my responsibility to report to the JUPAS Office in writing immediately should there be any changes to my identity document(s) which affect my status as "local" or "non-local" applicant as defined in the said EDB's Definition of Local Students (including any update / renewal of my identity document(s) ("Reporting Requirements")). My "local" status may change to reflect the changes to my identity document(s).
 - in particular, if my identity document(s) will expire on or before DD MMM YYYY:
 - I am required to submit, no later than DD MMM YYYY (11:00 PM), latest / renewed document(s) to the JUPAS Office in order to maintain my "local" status;
 - If I fail to provide the latest / renewed document(s) on or before DD MMM YYYY (11:00 PM), I will be considered as a Non-Local student ("NLS"). Although my application will still be processed by JUPAS, my application will be assessed by the 9 JUPAS participating institutions as NLS applying via non-JUPAS route*. NLS, when admitted by the JUPAS participating institutions, will be required to pay higher tuition fees than local students; and
 - after the submission deadline of DD MMM YYYY (11:00 PM), I may still produce the latest / renewed document(s) to the relevant Institutions for consideration during admission / registration (but not to the JUPAS Office which will not accept them after the said deadline). The relevant Institutions may take into account the latest / renewed document(s) in determining my "local" or "non-local" status; and
 - If I make any false statement(s) or omit to state any significant information in my application, or if I make a misleading representation concerning my application, or if I fail to comply with the "Reporting Requirements" as in paragraph 2.6 above, my application may be disqualified; the Institutions may withdraw and / or amend my offer, and / or cancel my registration / terminate my studies after admission, and / or any fees paid in connection with my application / offer will not be refunded or transferred to another year / offer application.

*NLS are not covered under the SSDP.

For Applicants who will be Submitting JUPAS Application Data in Mainland

 - If I will be submitting my JUPAS application data in Mainland, it is my responsibility to give my consent and understand this constitutes cross-border data transfer in accordance with the provisions of the Personal Information Protection Law of the People's Republic of China (Chinese version, English version), and I can request for withdrawal of consent via email at jpa@jupas.edu.hk.
 - If I have given my consent as specified in paragraph 2.9 AND I am under the age of 18 years at the time of my JUPAS account creation for 2025 Admissions Exercise, in accordance with the provisions of the Personal Information Protection Law of the People's Republic of China (Chinese version, English version), a Consent Form should be completed by my parent or guardian.
 - I understand that if I fail to provide a completed Consent Form, my application will not be processed; and
 - I understand that this consent shall lapse automatically upon I reaching the age of 18 years; and
 - If I withdraw my consent under the age of 18 years, my application will not be processed.
