- a. You have learnt Chinese Language for less than 6 years while receiving primary and secondary education; or
- b. You have learnt Chinese Language for 6 years or more in schools, but have been taught an adapted and simpler curriculum not normally applicable to the majority of applicants in local schools.

The Apl(C) results, if applicable, registered at the HKEAA will be obtained by the JUPAS Office, the 9 JUPAS participating institutions and the SSSDP institutions from the HKEAA directly. You **NEED NOT** indicate your Apl(C) results under "Alternative Qualification(s) in Chinese Language (ACL)" in your JUPAS account and / or submit such results to the JUPAS Office.
